

**REGULAR MEETING – WEDNESDAY AT 5:00 P.M.**

The Switzerland County Council met in regular session pursuant to law and by being duly advertised.

Those present: council: Tom Conroy, Steve Crabtree, Jeff Darling, Terry Hall, Mike Jones, Rachel Schuler, and Glenn Scott, the sheriff, Roy Leap, and the auditor, Gayle Rayles. Attorney Cody Kendall was absent.

The meeting was opened by Roy who also led the pledge of allegiance.

The minutes of the previous meeting of July 10<sup>th</sup> were approved as presented on a motion by Tom, seconded by Steve and all agreed.

**#1 Katie Collier – S.W.C.D.**

Katie came to inform the council that her office is helping the county with the Grants Creek mitigation with identifying the invasive species on the property. They signed off on that last week. She also wanted to let them know that the Indian Creek Watershed Project has received another implementation grant of \$200,002.00. She invited council to their first steering meeting concerning this on Monday at 7:00 p.m. at the annex.

**#2 Linda Elam – East Enterprise Regional Sewer District – 2 Proposals**

Linda came to give council 2 proposals for the repair of manholes: Pemco International (\$89,700.00) and J.D. Reed (64,240.00). Jeff wanted to know if fixing these manhole covers would buy any time for fixing other things – Linda thought it should. A one inch rain will increase their ground water intake by about 100,000 gallons.

After much discussion, Steve made a motion to go with the low bid of J.D. Reed, seconded by Glenn and all agreed. Claims are to be paid by the auditor's office out of the Rainy Day Fund. Glenn recommended that the last payment not be made until Linda and the board is satisfied.

**#3 Nancy Barker – AIC Meeting**

Nancy came to ask for financial support from council for the AIC meeting that is to be held at Belterra in September. They are expecting about 800 people. Steve said he had received \$2,500.00 from the AIC, some from the EDC, and he has asked tourism for some financial support. The guest county normally gives a gift to all that attend the conference; Ohio County is also sponsoring the AIC meeting and giving gifts.

The AIC committee thought that maybe Switzerland County could give a bottle of wine to each attendee, since we have a local winery, at a cost of \$8.00 per bottle already boxed; a bicentennial bottle.

The place for the AIC meeting is bid out every time – so it is a really big deal for Switzerland County. Nancy and the committee are asking for \$3,200.00. Terry made a motion to approve up to \$5,000.00, or only what they would actually need after other donations, seconded by Tom and motion carried with 1 nay (Glenn).

**#4 Martha Bladen & Anita Danner – Historical Society – Parking Lot**

Anita and Martha came to ask for some financial support for the Historical Society.

Anita said that 3 years ago she came to council with the goal of raising \$200,000.00 and \$50,000.00 was committed by council. They have now raised the \$200,000.00 and have received a grant from the Jeffrey's Foundation.

They are asking for \$27,500.00 for a new parking lot at the Thiebold House, on SR 56 below Vevay. They already have part of the money for the total cost of \$85,000.00 from other resources. INDOT has already approved the plans and Glenn Gosnell is to do the excavation work.

Steve made a suggestion of approving \$11,000.00 if tourism would approve \$11,000.00. Glenn asked if they would still have enough money to build the parking lot if council did not contribute any funds – the answer was “no”. The riverboat revenue they receive goes toward operation as well as other expenses. They rely a lot on donations.

Steve made a motion to make a commitment to the Historical Society for \$11,000.00, a 50/50 split with tourism, which was seconded by Terry. The motion carried with the money to come from the Rainy Day Fund.

**#8 AIC Conference**

The annual AIC conference is to be held in Switzerland County this year at Belterra on September 23<sup>rd</sup> through the 25<sup>th</sup>. Mike and Steve urged the other council members to at least go to the meeting within the conference that the state puts on for all council members.

Frank Cummings is to attend the next council meeting on the 11<sup>th</sup>.

The treasurer has pointed out to Gayle that since there was no money allotted for extra-clerical, if one of them was on vacation and the other one got sick or had an emergency they would have to close the office. Rachel said they would have to come back to council if a situation arose.

With no further business to come before council, Rachel made a motion to adjourn, seconded by Tom and all agreed. The meeting adjourned at 6:33 p.m.
