#### **REGULAR MEETING – 5:00 P.M.**

The Switzerland County Council met in regular session pursuant to law and by being duly advertised.

Those present: council: Mike Bear, Terry Hall, Elizabeth Jones, Rachel Schuler, Glenn Scott, and John Gary Welch, the sheriff, Nathan Hughes, council attorney, Cody Kendall, and the auditor, Gayle Rayles. Councilman Steve Crabtree came in later.

The meeting was opened by Nathan who also led the pledge of allegiance.

The minutes of the previous meeting of February 11<sup>th</sup> were approved as presented on a motion by Elizabeth, seconded by Mike and all agreed.

### #1 Aaron Bell - SEIRD - Annual Report

Aaron came and gave each council member some information about the recycling center and what happened in 2014. He explained that they served 7 area counties. He said they saw a 20% increase in a year's time in the curb-side recycling. Also in the past year they recycled 250,000 pounds of electronics. The 2 satellite containers usage has gone up about 30% over the past year and the school recycling goes up every year. Household participation has also gone up about 30%. Aaron thanked them for the support from Switzerland County.

### #2 Martin Justice - Switzerland County Awareness Team

Martin came to give the annual report for the Switzerland County Awareness Team (SCAT). They are funded by court fees that are used for prevention, treatment, and law enforcement. This year they have \$2,500.00 for each of the 3 categories.

There will be an incentive pay amount of no more than \$4000.00 for the year paid semi-annually in installments not to exceed \$2000.00 for each sheriff's merit deputy, jail commander, jail matron, and communications/E911 director based on performance. The incentives are to be paid no more than twice a year in May and November.
