#1 Shannon Jackson – Florence Regional Sewer District (FRSD)- Funding Request

Shannon Jackson, Vickie Hinman, and Steve Lyons came on behalf of the FRSD to inform the council of their upcoming improvement plan and to request funding assistance.

Shannon had the engineering report from Midwestern Engineering which Susie will send to the council members. The total cost will be \$1,925,000.00 and will include construction costs, permitting, admin costs, etc. They have applied for a grant with an award date of August 27, 2021. The district is asking for help with the 25% matching amount of \$381,250.00. This is not the total 25% amount as they are asking other entities for assistance.

They would like to come back to a meeting after August 27, 2021, to discuss this further. The total project amount is \$1,925,000.00.

#2 Sheriff Brian Morton – 2022 Budget

Brian came to answer any questions the council may have prior to the 2022 budget meetings tomorrow. He basically did not raise his budget from the 2021 figures.

#3 Jacque Clements – 2022 Budget

Jacque was in attendance by telephone. She explained the levy numbers and that the county is showing a 4.3% growth or about \$110,000.00. The General Fund budget is currently \$150,000.00 over levy which is ok to advertised.
