Patty Jackson conducted the public hearing for application Switzerland County is submitting to the Indiana Office of Community and Rural Affairs. Patty spoke about the grant and what in can do within the county and could possibly help 24 families. The deadline will be August 7<sup>th</sup> and she had applications with her. 


